PVG COORDINATORS – BISHOP'S APPROVAL

Thank you to all those coordinators already submitting the Annual Checklist – very much appreciated. However, a note about Bishop's Approval. We have had a few cases recently where we are notified about the appointment of a new Coordinator, but no approval has been sought from Bishop John <u>before</u> they start work. The SEC Policy is:

"When the Vestry has identified a suitable candidate, the Vestry Secretary should seek references (which should be sent to the Bishop) and ask the Bishop to approve the appointment."

Simon Filsell will then send, if approved, a letter to the Rector/Priest in Charge. A Coordinator does not need to be PVG-checked themselves, as they are not necessarily working directly with vulnerable people, so this is a very important part of the safeguarding process. The PVG Coordinator has to make sure that PVG checks are done on all relevant staff/volunteers so the Bishop's approval is a process to verify suitability for this crucial role.

MINISTERIAL DEVELOPMENT OFFICER

At the recent Mission & Ministry Committee meeting it was confirmed that The Revd Jane MacLaren will not be returning to her MDO role after an extended period of absence since contracting Covid back in March. She continues her work as Priest in Charge of St Philip's & St James' in Edinburgh. The Committee will now look at the options for recruitment.

ANNUAL FORMS

Vestry Secretaries and Rectors/Priests in Charge will be thrilled to learn that it is time for these forms to be submitted once more. In an effort to further ease the process and reduce the time, we have sent out the database printout sheet for each individual congregation to the respective Vestry Secretary in the post. That can either be returned "no changes" or an online form can be used to confirm any new details.

Please let us know if your Vestry Secretary has not received theirs.

The Rectors/Priests in Charge are being asked to complete the Congregational Statistics which, again, is

via an online form: https://edinburgh.anglican.org/diocesan-vestry-resources/resources-diocesan-office-forms/ This year, we have added the list of questions as a separate document, to help you get the numbers ready before you start!

For PVG Coordinators – we have just (in the last few days) received the 2022 PVG Checklist from the General Synod Office, so we will get the new questions revised in the Google Form and let you know when that's ready to go.

NATIONAL CHURCHES TRUST: MAINTENANCE GRANT

The Foundation Grant Programme offers our small grants of between £500 and £5,000 towards urgent maintenance works and small repairs identified as high priority within a recent Quinquennial Inspection or Survey Report. Also, small investigative works and surveys. Project costs should be up to £10,000 excl. VAT and awards will never exceed 50% of the costs. Decisions are made on a rolling basis.

Non-Domestic Alternative Fuel Payment - users for testing support

The Department for Business, Energy and Industrial Strategy (BEIS) hopes to be put in contact with users that will be able to test the proposed energy support package.

BEIS are looking for:

- I. Contacts with the authority to apply for support on behalf of their organisation/building with access to information such as invoices, building records and heating bills
- 2. Representing organisations operating in buildings that are **non-domestic**, **off the gas grid**, and using **large quantities kerosene for heating** (for instance above 10,000 litres per year)
- 3. Contacts would need to be able to participate in remote usability testing sessions of around 60 minutes, with internet access and Microsoft Teams enabled. We can offer a payment of £50 per interview

- "It's built up my confidence and it pushes you to do something you wouldn't normally do. This place helps you build yourself back up."

'Anglican' Christianity: A four-part series in Advent 2022

What does it mean to be an 'Anglican' Christian?

Over 40 Churches around the globe, consisting of no less than 85 million people, identify themselves as 'Anglican'. Yet, Anglicans are divided among themselves in terms of doctrine and practice as demonstrated in the most recent Lambeth Conference (Summer 2022). This Series looks to four staples that Anglicans have classically identified as the bases of their belief and behaviour to highlight harmony rather than discord.

The Series will be offered on the Mondays of Advent 2022 at 7pm (GMT) in four 30-minute webinars, each of which will be posted on YouTube. The Series is meant to be a resource for Anglicans/Episcopalians to use creatively during the Season of Advent, for example as a refresher course for individuals or a conversation starter for church groups, with discussion questions at the end of each webinar.

- 1. Holy Scripture: 'all things necessary to salvation' and the rule of faith (Monday 28 November)
- 2. The Apostles' and Nicene Creeds: symbols and statements of faith (Monday 5 December)
- 3. The Dominical Sacraments: Baptism and the Lord's Supper (Monday 12 December)
- 4. The historic Episcopate: a universal and locally adopted means of unity (Monday 19 December)



New Convener sought for Ethical Investment Advisory Group

A convener for the reconstituted Ethical Investment Advisory Group (EIAG) is being sought, and any lay or ordained members of the SEC who are interested in the position are being encouraged to get in touch.

In June this year General Synod adopted the revised Ethical Investment Policy Statement for the SEC Unit Trust Pool (UTP). Drafting this was the final part of the remit of the EIAG which had been set up to look at specific issues relating to the UTP arising from General Synod 2019.

Standing Committee has agreed that EIAG should be reconstituted with a new remit, and is now seeking someone to convene the new group for the next five years. An interest in Christian ethics and a basic knowledge of investments is essential. The ethics of investments are complex and the convener will have oversight of a group where differing views are held in tension. The group will work closely with Investment Committee and report to Standing Committee.

The focus of the new group will be to provide advice to Investment Committee on matters relating to ethical investment, principally to consider how the broad aspirations in the Ethical Investment Policy Statement and the associated Policy on the use of Pooled Funds (2019) can be put into practice for the UTP. It is envisaged that the work will include discussion of topics recommended and requested by Standing Committee and other committees, as well as responding to concerns raised by members of the SEC in relation to the implications of current events.

The overarching aim will be to provide advice that is grounded in Christian theology, but practicable for Investment Committee to implement.

It is anticipated that the group will meet twice a year either online or in person at the General Synod Office.
